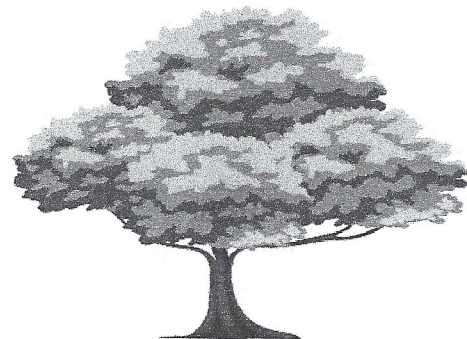
## Summer Time is here!

## NEIGHBORHOOD DIRECTORY

The Sherwood Forest West HOA is working on an updated neighborhood directory for our residents. The newest directory is 10 plus years old and in need of some serious updating. Past directories have had listings alphabetically by name address and also had listings by street addresses and resident name. This makes it possible to identify a resident with a given address. The information provided is a resident's name, address and telephone number. We would like to do an update with a similar format, but also add an email address as well. The board realizes that some residents are reluctant to provide phone numbers and email address and that is understandable. The directory is for the use of Sherwood Forest West residents only. An example for use would be in case of an emergency, residents could possibly reach their neighbor if that resident is not home and there is a problem at their home. Any information that the HOA has is for HOA use **only** in the conduct of its business with residents and **will not** be distributed to any other entities.

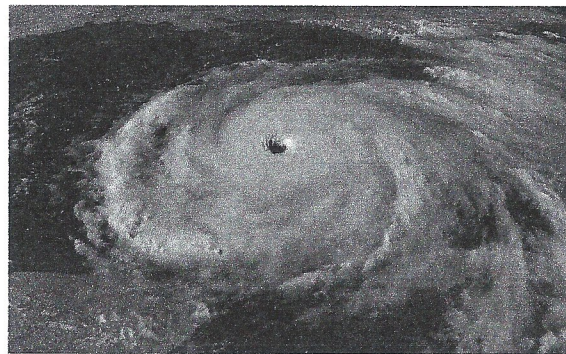
